

## MEMBERSHIP PROGRAM TERMS & CONDITIONS

The membership QR code is strictly designated for personal use and is **non-transferable**. Any unauthorized transfer, sharing, duplication, or illicit use of the QR code is strictly prohibited and will result in severe consequences, including immediate termination of the membership and imposition of **penalties. All associated benefits and privileges will also be revoked.**

The use of bracelets or QR codes is allowed only for those who resides in Caesar Projects and it is prohibited for non-residents, including Owner's guests and visitors. The formal statement of the Owner will be required. Not following the rule will cause a suspension of the membership for **6 months**.

1. We provide the membership only upon signing **sales agreement and duly payment of the applicable maintenance fees**.
2. Only Owners and Long Term Tenants are eligible for membership program. Long Term Tenants are considered the ones who stay **90+** days forprivately rented by owners as well as by Afik Rental Long Term Tenants shall provide **registered** long term rental agreement upon applying for the membership.
3. Short term clients of Rental office are eligible to enter all facilities with bracelets provided upon check-in, the bracelets must be returned to reception on the check-out.
4. Owner's clients staying from **1-90** days will be eligible to use all facilities by coming to reception office and registering. Reservation confirmation **or** confirmation email from the owner will be required. The email should include the following details:
  - Name and number of the apartment.
  - The vacation dates (arrival day - departure day).
  - Full name and passport number of the guests (for all the gusests).

**NOTE: Returning bracelets to Membership Department is essential. No new braclets will be provided until the old ones are returned back.**

5. Number of registrations under each apartment:

**Studio – 2 people**  
**1+1 – 3 people**  
**2+1 – 5 people**  
**3+1 – 7 people**  
**4+1 – 9 people**

**(First Family Relationship Only)**

6. Up to 48 hours is required for the Membership Program Team in order to check the data and reject or approve it.
7. Non residing family members/short term visiting family members and friends of owners can visit Aqua park, however with surcharge and with conditions of owner to be present at the entrance with them with an **active and approved QR code**.
8. Children's up to 3 years old – FREE OF CHARGE | Over 3 years old & adults – 350 TL

## BENEFITS & DISCOUNTS
